Regional Water Resource Agency Engineering Services – Combined Sewer System Hydraulic Modeling REQUEST FOR QUALIFICATIONS # 2025-25

INTRODUCTION

The Regional Water Resource Agency (RWRA), the municipal sewer utility for Owensboro-Daviess County, Kentucky, is seeking the professional services of a qualified individual or firm to build and calibrate a comprehensive hydrologic and hydraulic model of the combined sewer system (CSS) of Owensboro, use this model to analyze existing conditions, predict overflow volumes based on rainfall amount, and recommend a series of improvements to the system for overflow reduction and minimized local flooding.

DUE DATE AND TIME

All interested consultants shall submit their qualifications to the location listed below no later than 2:00 pm local prevailing time on February 12, 2025; at this time the name of each individual firm submitting qualifications will be announced. The RFQ will not be publicly opened at this time. Any submittals received after the due date and time will be returned unopened.

GENERAL COMPLIANCE

QUALIFICATION SUBMISSION: The signed completed original qualification package and copies must be sealed in an envelope with the consultant's name, the qualification number (2025-25), and the Request for Qualification due date clearly marked on the outside of the envelope. The Submittal of Statement of Qualifications shall be addressed and delivered to Regional Water Resource Agency, Attn: Tonya Smith, Purchasing and Administration Manager, East Treatment Plant, 1722 Pleasant Valley Road, Owensboro, KY 42303.

QUALIFICATION COPIES: When submitting qualifications, include the original signed Statement of Qualification, along with three (3) copies of the entire submittal. The original Statement of Qualification and all copies shall be submitted in one envelope.

QUALIFICATIONS: The firm/individual must demonstrate to the satisfaction of RWRA that it has adequate personnel, experience and understanding of the project to perform all tasks required within the scope of the project and is licensed to practice Engineering in the State of Kentucky.

No contract will be awarded to any firm/individual who, in the opinion of RWRA, is not qualified to perform satisfactorily due to a previous unfavorable performance, reputation or lack of experience, capital, organization, and/or personnel to conduct and complete the services in accordance with the terms and conditions of the contract.

DISQUALIFICATION FROM FUTURE RFQs: Any firm/individual awarded a contract that fails to fulfill all obligations of contract may be disqualified from submitting a bid or proposal on any Regional Water Resource Agency projects for a period of up to five (5) years.

CONDITIONS OF QUALIFICATIONS: All cost incurred in the preparation of a submittal responding to this RFQ will be the responsibility of the Offeror and will not be reimbursed by RWRA.

METHOD OF AWARD: This Submittal of Statement of Qualification will be evaluated based on the evaluation criteria established in this RFQ.

It is expected that written or oral discussions may be conducted with responsible offerors that are being considered by RWRA for the award. Discussions shall not disclose any information derived from qualifications submitted by competing offerors. Respondents may be asked to submit a pricing schedule and/or estimate at the time of evaluation. An award without any discussions, based on initial qualification, may be made as provided for in KRS 45A.370(3).

The RWRA reserves the right to reject any and all submittals and to waive any irregularities in said submittals, and the RWRA also reserves the right to award a contract based on the best interest and/or most advantageous to RWRA.

Requests for additional information (RFI) or clarifications of this RFQ should be directed to Tonya Smith, Purchasing and Administration Manager, Telephone (270) 687-8440 or by e-mail to bids@rwra.org. RFIs will only be considered if submitted no later than 3 business days prior to the Qualification submission due date.

COMPLIANCE WITH APPLICABLE LAWS/REGULATIONS: Successful firm/individual must comply with City of Owensboro/Daviess County ordinances relating to Occupational License Fees, Business Licenses, payroll and net profits taxes and any other ordinances which may apply to any qualification package.

COMPLIANCE WITH EQUAL OPPORTUNITY STATUTES: The Regional Water Resource Agency is an equal opportunity employer and does not discriminate on the basis of race, color, religion, sex, national origin, age, marital status, physical or mental disability, or any other characteristic protected by law. RWRA is also committed to employing only United States citizens and aliens who are authorized to work in the United States and complies with the Immigration Reform and Control Act of 1986.

Therefore, the successful Consultant must demonstrate to the satisfaction of RWRA that he also conforms to all Federal, state, and local equal opportunity statutes. Further, the consultant will reimburse RWRA for any damages incurred due to any violation of the above-mentioned statutes by the consultant while under contract.

INDEMNITY AGREEMENT: The successful consultant shall be required to sign and have notarized the attached RWRA "INDEMNITY AGREEMENT" or their submittal will not be considered (Appendix A).

BONDING: There is no bond required.

COMPLIANCE WITH KRS 45A.343 AND KRS 45A.395: Attached are statements which must be completed by offerors. These statements are required under the listed statutes and must be completed and submitted with the proposal (Appendix B & C).

Kentucky law prohibits conflicts of interest, gratuities, kickbacks and the use of confidential information with regard to any public contract or a solicitation or proposal, therefore. The prohibitions are set for in KRS 45A.455 which provides:

- (1) It shall be a breach of ethical standards for any employee with procurement authority to participate directly in any proceeding or application; request for ruling or other determination; claim or controversy; or other particular matter pertaining to any contract, or subcontract, and any solicitation or proposal therefor, in which to his knowledge:
 - (a) He, or any member of his immediate family has a financial interest therein; or
 - (b) A business or organization in which he or any member of his immediate family has a financial interest as an officer, director, trustee, partner, or employee, is a party; or
 - (c) Any other person, business, or organization with whom he or any member of his immediate family is negotiating or has an arrangement concerning prospective employment is a party. Direct or indirect participation shall include but not be limited to involvement through decision, approval, disapproval, recommendations, preparation of any part of a purchase request, influencing the content of any specification or purchase standard, rendering of advice, investigation, auditing, or in any other advisory capacity.
- (2) It shall be a breach of ethical standards for any person to offer, give, or agree to give any employee or former employee, or for any employee or former employee to solicit, demand, accept, or agree to accept from another person, a gratuity or an offer of employment, in connection with any decision, approval, disapproval, recommendation, preparation of any part of a purchase request, influencing the content of any specification or purchase standard, rendering of advice, investigation, auditing, or in any other advisory capacity in any proceeding or application, request for ruling or other determination, claim or controversy, or other particular matter, pertaining to any contract or subcontract and any solicitation or proposal therefor.
- (3) It is a breach of ethical standards for any payment, gratuity, or offer of employment to be made by or on behalf of a subcontractor under a contract to

- the prime contractor or higher tier subcontractor or any person associated therewith, as an inducement for the award of a subcontract or order.
- (4) The prohibition against conflicts of interest and gratuities and kickbacks shall be conspicuously set forth in every local public agency written contract and solicitation, therefore.
- (5) It shall be a breach of ethical standards for any public employee or former employee knowingly to use confidential information for his actual or anticipated personal gain, or the actual or anticipated personal gain of another person (Enact. Acts 1978, ch.100, S 92, effective January 1, 1980; ch.250, S16, effective April 9, 1980)

For further information on the conflict of interest statutes, see the "Recovery of value of anything transferred or received in breach of ethical standards" at KRS 45A.460, and "Definitions for terms used in KRS 45A.445 to 45A.460" at KRS 45A..445.

KENTUCKY PREFERENCE LAWS: Pursuant to KRS 45A.490-494, qualifiers are required to submit affidavit addressing Kentucky Preference Laws (Appendix D).

NON-COLLUSION STATEMENT: Vendors, by submitting qualifications, certify that the accompanying submittal is not the result of, or affected by, any unlawful act of collusion with any other person or company engaged in the same line of business or commerce, or any other fraudulent act punishable under Kentucky or United States law.

SAFETY: Consultant must perform work in a safe and timely fashion, maintain a clean and safe work environment, follow safety requirements established by OSHA, the Regional Water Resource Agency and comply with all federal, state, and local occupational safety and health laws and regulations.

INSPECTION: RWRA recommends that each firm visit the site to verify conditions pertinent to obtaining relevant information needed to complete the project. An Indemnity Agreement (Appendix A) must be completed, notarized and submitted prior to inspections and proof of permit-required confined space training (per OSHA standard 29 CFR 1910.146) is required prior to entering a permit-required confined space.

INSURANCE REQUIREMENTS: The successful consultant covenants and agrees to maintain and keep in force during the term of the contract, worker's compensation, property, casualty, and general liability from an "A" or better rated (by AM Best Rating System) insurance company in the following minimum amounts. Example Certificate of Liability Insurance can be found on last page.

The Regional Water Resource Agency shall be listed as "Additional Insured" in respects to the General Liability, Automobile and Excess/Umbrella Liability and shall further require that its liability carrier(s) notify RWRA at least thirty (30) days prior to the effective date of any change(s) in or cancellations of said insurance policies. A current copy of consultant's insurance certificate providing proof of insurance as stated above must be on

file with the RWRA Purchasing Manager prior to contract award. The firm awarded this project shall not limit their liability to the value of their fees, but only to the value of their insurance policy, meeting or exceeding the limits identified above.

Combined Sewer System Hydraulic Modeling

OBJECTIVES

The primary objectives of the project are to:

- 1. Develop and calibrate a hydraulic model of the RWRA collection system consisting of approximately 1500 links and 1500 nodes.
 - a. Model construction and development should consist of the following components:
 - i. Survey of critical elevations as determined by the Engineer.
 - ii. Flow meter installation for a period to collect sufficient rainfall data to accurately calibrate the model, with locations and time period agreed upon by the Consultant and RWRA Engineer.
 - iii. Rain gauges to be installed and collect data for the same period when flow meters are deployed. Locations to be agreed upon by Consultant and RWRA Engineer.
 - iv. All significant combined gravity sewers.
 - 1. Model should include collector sewers from all basins as well as lines that connect isolated sub-basins.
 - v. All CSS pump stations (3) and pump stations with major contributing flow to the treatment plants outside of the combined system (6).
 - vi. Eight (8) combined sewer outfalls (CSOs).
 - 1. Model should include impacts of water level of the Ohio River.
 - vii. Two (2) Wastewater Treatment Plants.
- 2. Provide hydraulic modeling training to RWRA staff to allow RWRA to operate the hydraulic model post-project.
- 3. Develop calculator from the model to estimate overflow volumes based on wet well elevations with the influence of the river elevation included.

BACKGROUND

The Regional Water Resource Agency (RWRA) is the comprehensive provider of public wastewater services for the Owensboro-Daviess County community, serving a population of approximately 80,000. The Agency operates a system consisting of two wastewater treatment plants (WWTPs), a combined sewer system (CSS) with eight Kentucky Pollutant Discharge Elimination System (KPDES) permitted combined sewer overflows (CSOs), a separate sanitary sewer system (SSS), and 56 total pump stations.

The CSS consists of three major basins: Center, Dublin, and Locust. Each basin terminates at the river with a large pump station that sends flow to the west treatment plant. Flow is diverted into the stations from a tunnel sewer with a weir that determines the overflow point. During a few overflow events a year, the river elevation is higher than the weir elevations, changing the overflow point for that event. Tide gate valves prevent the river from flowing into the station when the river is elevated, and system flows are normal.

On September 5, 2007, RWRA entered a Consent Judgement with the Kentucky Environment and Public Protection Cabinet to ensure that RWRA's CSO Program was in compliance with regulatory requirements. The Consent Judgment included development of a Long-Term Control Plan (LTCP) which was accepted in June 2017. RWRA is in the process of implementing projects in the accepted LTCP.

RWRA first began development of a collection system model in 1999 using United States Environmental Protection Agency Stormwater Management Model (USEPA SWMM). In 2006, the model was changed to XP Software – Stormwater Management Model (XPSWMM). The model was limited to including only the CSS. The model was recalibrated in 2016 for use in development of the LTCP.

RWRA wishes to abandon the existing hydraulic model and construct new. RWRA is most interested in a study of the CSS trunk mains as well as any smaller diameter collector sewers which serve subbasins within the system. Selection of the pipes to include in the model should be sufficient to identify excess or lack of capacity. The model shall also include major pump stations outside CSS (6) and both treatment plants to show any impacts of diverting flow out of the CSS and from the west treatment plant to the east treatment plant. The model will be utilized for sizing the remaining CSO / LTCP projects, long-term asset management, sewer connection request analysis, and on-going growth assessment. A calculator shall also be developed from the model to estimate overflow volumes for CSO reporting. The model and calculator must consider the elevation of the river during overflows to reflect differing conditions that will affect overflow volumes.

RWRA does not own any modelling software at this time and the new model must be constructed in a platform recommended to and agreed upon by RWRA. The selected firm will present the various model formats in a manner that allows RWRA to evaluate their user interface and abilities.

RWRA staff intends to update, evaluate, and assess the collection system model after the completion of the project. Training and support services will be required to ensure RWRA staff can maintain and update the collection system model in accordance with industry leading approaches and operate the model in the future.

AVAILABLE DATA

RWRA will provide the following data to the consultant for its use in construction of the model:

A recent copy of the GIS which includes gravity and force main pipe material, size, date of construction, and lining.

Rim and invert elevations of select manholes.

Local weather data from weather stations at 6 locations in or near the CSS with rain gauges.

Pump station data which includes pump run time and effluent rates.

Record drawings as requested by the consultant.

Other readily available information as the consultant may require.

SCOPE OF SERVICES

The engineering services required for this project are expected to be completed to meet the primary objectives of this project and in general accordance with a scope of services as needed to accomplish the tasks listed below. However, the final scope of services will be negotiated with the selected engineering firm and may include modified and/or additional tasks and a timeline with phasing of task.

- 1. Engineering services are likely to include the following tasks in phases:
 - I. Selection of model format and parameters, collection and review of existing data.
 - II. Flow, level, and rainfall metering with miscellaneous field work and physical model development.
 - III. Model calibration and validation.
 - IV. System assessment and analysis with recommendations and designs for improvements.
 - V. Workshops and training of RWRA personnel.

SUBMITTAL REQUIREMENTS

Each submittal must include the following to be considered:

1. FIRM DESCRIPTION AND STATEMENT OF QUALIFICATIONS

A brief description of the firm and any proposed subcontractors or subconsultants, and a statement of qualifications in relationship to the information requested.

Provide summaries for at least three (3) similar projects completed by key proposed team members for other clients, with an emphasis on Combined Sewer Systems. Identify who served as project manager and key lead technical roles in those projects

4. QUALIFICATIONS OF THE DESIGN TEAM

Identify specific personnel to be assigned to this project, including resumes of those persons detailing their experience on similar projects. Provide a one-page resume for up to five (5) key staff members.

5. REFERENCES

Provide project summary sheet and references for three (3) similar projects the firm has completed within the past five (5) years.

6. STATEMENT OF PROJECT UNDERSTANDING

and any other information required to demonstrate proposed plan for completing the aforementioned scope of services.

9. LOCATION OF OFFICE

Provide information regarding the locality of your team in comparison to the RWRA system and staff.

The submittal should include the following items:

QUALIFICATIONS OF CONSULTANTS

Consultant shall identify specific personnel to be assigned to this project, including resumes of those persons detailing their experience on similar projects. Qualifications shall also include a listing of firms or personnel outside of their firm whose services are anticipated to be utilized as part of the team.

RWRA will have a selection committee to review the submittals of Statement of Qualifications and determine through a selection process that includes qualifications of design team, experience in similar project, experience of key personal, experience with State/Federal funding agencies, ability of the firm to perform the work in a timely manner, and references.

REFERENCES

Consultant shall provide references for a minimum of three (3) successful projects of a similar nature. Each entry must include the date of the project, a general description of the project, client name, a contact person and telephone number and/or e-mail address. Statement of Qualifications submitted without the required reference information will not be considered.

KENTUCKY PREFERENCE LAWS

The scoring of bids/proposals is subject to Reciprocal preference for Kentucky resident bidders and Preferences for a Qualified Bidder or the Department of Corrections, Division of Prison Industries.

Reciprocal preference for Kentucky resident bidders

KRS 45A.490 Definitions for KRS 45A.490 to 45A.494.

As used in KRS 45A.490 to 45A.494:

- (1) "Contract" means any agreement of a public agency, including grants and orders, for the purchase or disposal of supplies, services, construction, or any other item; and
- (2) "Public agency" has the same meaning as in KRS 61.805.

KRS 45A.492 Legislative declarations.

The General Assembly declares:

- (1) A public purpose of the Commonwealth is served by providing preference to Kentucky residents in contracts by public agencies; and
- (2) Providing preference to Kentucky residents equalizes the competition with other states that provide preference to their residents.

KRS 45A.494 Reciprocal preference to be given by public agencies to resident bidders -- List of states -- Administrative regulations.

- (1) Prior to a contract being awarded to the lowest responsible and responsive bidder on a contract by a public agency, a resident bidder of the Commonwealth shall be given a preference against a nonresident bidder registered in any state that gives or requires a preference to bidders from that state. The preference shall be equal to the preference given or required by the state of the nonresident bidder.
- (2) A resident bidder is an individual, partnership, association, corporation, or other business entity that, on the date the contract is first advertised or announced as available for bidding:
- (a) Is authorized to transact business in the Commonwealth; and
- (b) Has for one (1) year prior to and through the date of the advertisement, filed Kentucky corporate income taxes, made payments to the Kentucky unemployment insurance fund established in KRS 341.490, and maintained a Kentucky workers' compensation policy in effect.
- (3) A nonresident bidder is an individual, partnership, association, corporation, or other business entity that does not meet the requirements of subsection (2) of this section.
- (4) If a procurement determination results in a tie between a resident bidder and a nonresident bidder, preference shall be given to the resident bidder.
- (5) This section shall apply to all contracts funded or controlled in whole or in part by a public agency.
- (6) The Finance and Administration Cabinet shall maintain a list of states that give to or require a preference for their own resident bidders, including details of the preference given to such bidders, to be used by public agencies in determining resident bidder preferences.

The cabinet shall also promulgate administrative regulations in accordance with KRS Chapter 13A establishing the procedure by which the preferences required by this section shall be given.

- (7) The preference for resident bidders shall not be given if the preference conflicts with federal law.
- (8) Any public agency soliciting or advertising for bids for contracts shall make KRS 45A.490 to 45A.494 part of the solicitation or advertisement for bids.

The reciprocal preference as described in KRS 45A.490-494 above shall be applied in accordance with 200 KAR 5:400.

Determining the residency of a bidder for purposes of applying a reciprocal preference

Any individual, partnership, association, corporation, or other business entity claiming resident bidder status shall submit along with its response the attached Required Affidavit for Bidders, Offerors, and Contractors Claiming Resident Bidder Status. The BIDDING AGENCY reserves the right to request documentation supporting a bidder's claim of resident bidder status. Failure to provide such documentation upon request shall result in disqualification of the bidder or contract termination.

A nonresident bidder shall submit, along with its response, its certificate of authority to transact business in the Commonwealth as filed with the Commonwealth of Kentucky, Secretary of State. The location of the principal office identified therein shall be deemed the state of residency for that bidder. If the bidder is not required by law to obtain said certificate, the state of residency for that bidder shall be deemed to be that which is identified in its mailing address as provided in its bid.

Preferences for a Qualified Bidder or the Department of Corrections, Division of Prison Industries.

Pursuant to 200 KAR 5:410, and KRS 45A.470, Kentucky Correctional Industries will receive a preference equal to twenty (20) percent of the maximum points awarded to a bidder in a solicitation. In addition, the following "qualified bidders" will receive a preference equal to fifteen (15) percent of the maximum points awarded to a bidder in a solicitation: Kentucky Industries for the Blind, any nonprofit corporation that furthers the purposes of KRS Chapter 163 and any qualified nonprofit agencies for individuals with severe disabilities as defined in KRS 45A.465(3). Other than Kentucky Industries for the Blind, a bidder claiming "qualified bidder" status shall submit along with its response to the solicitation a notarized affidavit which affirms that it meets the requirements to be considered a qualified bidder- affidavit form included. If requested, failure to provide documentation to a public agency proving qualified bidder status may result in disqualification of the bidder or contract termination.
